by the applicant.

9. HALAL SHIPMENT CERTIFICATE FOR SAUDI ARABIA (MEAT & OTHER THAN MEAT)

- 9.1 As per Halal Center –SFDA requirements, a Halal Certified facility additionally needs to be registered on Saudi Halal Center Portal, before starting business in Saudi Arabia, and also consignment certificate needs to be obtained from the Saudi Halal Center Portal.
- 9.2 Facility Registration and consignment certificate can be obtained through Halal Center recognized Halal body, e.g. JUHF
